1. **PAYMENT TERMS.** You authorize Global Medici Ventures PTE. LTD. to process the credit card information you have provided to Global Medici Ventures PTE. LTD., in the amount set forth on the Agreement, for the Membership. You acknowledge and agree that Membership services do not include travel or lodging, and such travel or lodging expenses incurred by You shall be Your sole responsibility and shall be in addition to any Fee for the Membership.
2. **MEMBERSHIP RENEWAL.** The annual fee for the Medici GOLD Membership is €6,000. The Membership is subject to automatic renewal, unless you provide written notice of cancellation to billing@medicilegacy.com no less than three months prior to the end of the membership year.

LTD. retains all right, title and interest in any and all intellectual property related to or associated with the Program services, including without limitation: (a) trademarks and copyrights; and (b) any other proprietary right arising under the laws of Singapore. LTD. shall constitute a transfer, assignment, or license of any intellectual property rights from or by Global Medici Ventures PTE. LTD.. You acknowledge that the content of the Program services, including without limitation the materials and information provided to You as education, is confidential and proprietary to Global Medici Ventures PTE. LTD.; accordingly, You agree that You shall not communicate the teachings, materials, or information acquired or learned from Global Medici Ventures PTE. LTD. to any other person.
6. **CONTACTS.** By paying your first invoice you agree that Global Medici Ventures PTE. LTD. may call and text You regarding Your account information and regarding other offers, products, and services, including through the use of automated dialing equipment and pre-recorded messages, and that this consent is not a condition of purchase.
7. **INDEMNITY.** You agree to protect, defend, indemnify and hold harmless Global Medici Ventures PTE. LTD., its officers, directors, employees or their invitees, from and against all claims, demands, and causes of action of every kind and character without limit arising out of Your receipt of Program services or actions taken in response thereto. Your indemnity obligation includes, but is not limited to, any claim for personal injury s sustained while traveling to or attending any seminar or other in-person training provided by Global Medici Ventures PTE. LTD. to You.
8. **LIMITATION OF LIABILITY.** You agree that in no event shall Global Medici Ventures PTE. LTD.’s liability to you for any claim of any kind or description exceed the amount paid by you to Global Medici Ventures PTE. LTD. in the twelve months preceding the event giving rise to any claim by you. You waive any right to special, indirect or consequential damages of any kind or description.

9. **FORCE MAJEURE.** Except for the duty to make payments hereunder when due, and the indemnification provisions under this Agreement, neither Party shall be responsible to the other for any delay, damage, or failure caused by or occasioned by any act of God, act of nature or the elements, terrorism, insurrection, or any other causes (except financial) beyond the control of either Party.
10. **ARBITRATION.** Any claim or grievance of any kind, nature or description that You have against Global Medici Ventures PTE. LTD. shall be resolved exclusively in final and binding arbitration before a single arbitrator selected by Global Medici Ventures PTE. LTD. within a reasonable time of You giving notice of arbitration to Global Medici Ventures PTE. LTD.. Arbitration shall be held in Global Medici Ventures PTE. LTD.. You agree not to file suit in any court against Global Medici Ventures PTE. LTD., any of its affiliates, subsidiaries, officers, directors, or employees. The arbitration will be subject to the rules of the American Arbitration Association and the Federal Arbitration Act, 9 U.S.C. §§ 1-16 ("FAA"). The arbitrator shall have the exclusive and sole authority to determine whether any dispute is arbitrable. The decision of the Arbitrator will be final and binding on the Parties, subject to appeal only under the FAA, and may be reduced to a judgment in any court of competent jurisdiction. You agree that each Party shall bear its own costs and attorneys' fees in any arbitration or litigation, regardless of which Party, if either of them, is deemed the prevailing party. Any claim must be brought in arbitration within one (1) year of the claim arising or forever be barred. This agreement to arbitrate survives any termination or expiration of the Agreement as well as bankruptcy or insolvency of either Party. Nothing in these Terms and Conditions prevents Global Medici Ventures PTE. LTD. from applying to and obtaining from any court having jurisdiction a temporary injunction, preliminary injunction, permanent injunction, or other relief available to protect Global Medici Ventures PTE. LTD.'s interest prior to, during, or following the filing of any arbitration or other proceeding.
11. **WAIVER OF CLASS ACTION** You understand and agree that You will not have the right to participate in a representative capacity or as a member of any class of claimants pertaining to any claims that may arise under, or be in any way related to, this Agreement, or Global Medici Ventures PTE. LTD. Claims brought against Global Medici Ventures PTE. LTD. may not be joined or consolidated with claims brought by anyone else.
12. **GOVERNING LAW.** This Agreement shall be governed, construed, and interpreted in accordance with the laws of Singapore without regard to any choice of law provisions.
13. **SEVERANCE.** In the event any provision of the Agreement or these Terms and Conditions is inconsistent with or contrary to any applicable law, rule, or regulation, the provision shall be deemed to be modified to the extent required to comply with the law, rule, or regulation, and this Agreement and these Terms and Conditions, as so modified, shall continue in full force and effect.
14. **NO ASSIGNMENT.** The Agreement cannot be assigned by You to another Party without the express written consent of Global Medici Ventures PTE. LTD.
